For this criterion, Applicant shall be required to attach a certificate issued by Chartered Accountant certifying the year-wise turnover of the Corporation / Company / Firm / LLP / Trust/ Society (including FPO/Cooperative). Turnover and net worth certificate shall also be accepted for the financial year ending in March, 2026.	Applicant must have turnover as per the following categories: Category A: (Master/Cluster Franchise /Private Entities): (I) Minimum turnover of Rs.10 Cr for each three Consecutive financial years 2023-24, 2024-25 and 2025-26 (audited or Provisional) (II) CA Certified Net-worth certificate Category B: (PACS/FPOs/SHGs/ Single store operators): (I) Minimum turnover of –Rs. 25lakh to Rs. 1 Cr turnover 2023-24, 2024-25 and 2025-26 (audited or Provisional) (II) CA Certified Net-worth certificate Applicant shall be required to attach a certificate issued by Chartered Accountant certifying the year-wise turnover of the Corporation / Company / Firm / LLP / Trust/ Federation/ Society (including FPO/Cooperative). Turnover and net worth certificate shall also be accepted for the financial year ending in March, 2026.
